ISSUE

What is Budget 2021 proposing to support housing?

KEY FACTS

- \$2.5 billon over 7 years in additional funding.
 - An additional **\$1.5 billion for the Rapid Housing Initiative** to add a minimum of 4,500 units with 25% dedicated to women-focused housing projects.
 - **\$600 million** over 7 years to expand the Affordable Housing Innovation Fund and create an additional 12,700 units.
 - **\$315.4 million** over 7 years for the Canada Housing Benefit to support women and children fleeing family violence.
 - **\$118.2 million** over 7 years through the Federal Community Housing Initiative to support community housing providers that deliver long-term housing to many of our most vulnerable.
- **\$1.3 billion** over 2 years (existing funding that will be advanced and reallocated).
 - **\$750 million**, advanced to 2020-2021 and 2022-2023 under the National Housing -Co-Investment Fund for the creation of 3,400 units.
 - \$250 million under the National Housing Co-Investment Fund to construct, repair and operate 560 units of transitional housing and shelters for women, this includes \$50 million for operating costs.
 - \$300 million in 2021-2022 and 2022-2023 from the Rental Construction Financing Initiative to convert excess commercial property into 800 rental market housing units.
- **\$4.4 billion** over five years, starting in 2021-22, to help homeowners complete home retrofits through interest-free loans.
- **\$25 million** to the Government of the Northwest Territories for the construction of 30 public housing units (delivered through CIRNA).
- **\$25 million** for the Government of Nunavut for the refurbishment or construction of 100 new housing units (delivered through CIRNA).
- An additional **\$567 million** over two years for Reaching Home to maintain the 2020-2021 funding levels (delivered through ESDC).

\$45 million over two years, for a pilot program aimed at reducing veteran homelessness through the provision of rent supplements, and wraparound services (delivered Through ESDC).

RESPONSE

- Mr. Speaker, the COVID-19 pandemic has widened gaps in Canadians' access to housing. Safe and affordable housing is critical for building strong communities.
- Building on the National Housing Strategy, the Government plans to invest an additional \$2.5 billion and reallocate and accelerate \$1.3 billion in existing funding for the construction, repair, or support of 35,000 affordable housing units.

- The Government is also proposing Canada's first national tax on vacant or underused residential property owned by foreign non-residents, to ensure that Canada's housing market remains accessible for Canadians starting their families and building their future.
- These measures will help families, young people, low-income Canadians, people experiencing homelessness, and women and children fleeing violence find a safe and affordable place to call home.
- We also know that climate action starts at home. That's why Budget 2021 also proposes to provide \$4.4 billion to help homeowners complete deep home retrofits through interest-free loans worth up to \$40,000 and help Canadians reduce their energy bills.

BACKGROUND

Co-operative Housing Federation of Canada (CHF)

"The Federal Community Housing Initiative is a lifeline for low-income households living in co-op and non-profit housing in many communities," says CHF Canada President, Tina Stevens. "This expansion of the Initiative will ensure that more lowincome households in federally administered co-op and non-profit housing can live affordably, bringing needed housing stability and security to those households, and the co-op and non-profit communities in which they live."
