ISSUE

What is Budget 2022 proposing to support housing?

KEY FACTS

Budget 2022 announced:

- \$4 billion over five years, starting in 2022-23, to launch a new Housing Accelerator Fund (HAF) creating 100,000 net new housing units.
- \$1.5 billion over two years, starting in 2022-23, to extend the Rapid Housing Initiative (RHI). This new funding is expected to create at least 6,000 new affordable housing units, with at least 25 per cent of funding going towards women-focused housing projects.
- Reform of the **Rental Construction Financing Initiative (RCFi)** by strengthening its affordability and energy efficiency requirements.
 - RCFi will target a goal of having at least 40 per cent of the units it supports provide rent equal to or lower than 80 per cent of the average market rent in their local community.
- Advancement of \$2.9 billion in funding, on a cash basis, under the National Housing Co-Investment Fund, so that all remaining funds will be spent by 2025-26.
 - This will accelerate the creation of up to 4,300 new units and the repair of up to 17,800 units
- Reallocation of \$500 million of funding on a cash basis from the National Housing Co-Investment Fund to launch a new Co-operative Housing Development Program aimed at expanding co-op housing in Canada.
- Reallocation of \$1 billion in loans from the Rental Construction Financing initiative to support co-op housing projects.
- \$200 million in dedicated support under the existing Affordable Housing Innovation Fund to help develop and scale up rent-to-own projects across Canada. This will include \$100 million to support non-profits, co-ops, developers, and rent-to-own companies building new rent-to-own units.
- Extension of the First-Time Home Buyer Incentive to March 31, 2025.
- **\$26 million** to support homeowners in Quebec whose homes require remediation from damages to foundations caused by the mineral pyrrhotite.
- **\$475 million** in 2022-23 to deliver a one-time \$500 payment to those facing housing affordability challenges.
- **\$5 million** over two years, starting in 2022-23 to develop and implement a **Home Buyers' Bill of Rights** and bring forward a national plan to end blind bidding.
- \$300 million over five years, starting in 2022-23, to co-develop and launch an Urban, Rural, and Northern Indigenous Housing Strategy.
- Additional \$458.5 million to the Canada Greener Homes Loan program to provide low-interest loans and grants to low-income housing providers.

RESPONSE

- Mr. Speaker, Canadians are challenged to access safe and affordable housing. This is why Budget 2022 takes significant steps that will build more homes and make housing more affordable across the country.
- Budget 2022 includes measures to expand Canada's housing supply and increase investments in affordable housing. We will double our housing construction over the next decade and invest in the rental housing that so many count on.
- Our government is proposing \$4 billion to launch a new Housing Accelerator Fund that will help create 100,000 new housing units by accelerating the planning and delivery of housing.
- The Rapid Housing Initiative has been a tremendous success so far and has exceeded its original goals. Building on this accomplishment, we are proposing to extend this initiative by \$1.5 billion to create at least 6,000 new affordable housing units.
- Budget 2022 proposes to advance \$2.9 billion in funding, under the National Housing Co-Investment Fund, accelerating the creation of up to 4,300 new units and the repair of up to 17,800 units for the Canadians who need them most.

BACKGROUND
