### What is Vendor Diversity at CMHC?

At CMHC, diversity, equity and inclusion are part of the core values that guide everything we do – both internally and externally. One of our goals is to achieve greater inclusiveness for diverse vendors in our procurement process.

CMHC recognizes the social and economic benefits of having diverse vendors and wishes to continue contributing to an inclusive Canadian economy. Reaching out directly to groups traditionally underrepresented in our procurement process is a key part of our strategy.

We have implemented policies and practices that promote fairness and inclusion. Our Vendor Diversity Program is part of CMHC's overall diversity, equity and inclusion effort, as defined in our organization strategy.

**Note:** This is not a guarantee that vendors will secure business with our organization, but rather a means to ensure that all vendors, including diverse vendors, are treated fairly and equitably in our procurement process.

#### What is a Diverse Vendor?

Consistent with Public Services and Procurement Canada's guidelines, CMHC defines a diverse vendor as a business owned or led by Canadians from underrepresented groups, such as Women, Indigenous Peoples, 2SLGBTQIA+, Persons with disabilities and Visible/Racialized communities. Each business is defined as being owned, operated and controlled by 51% of a given group.

## Why Have a Vendor Diversity Program?

The Vendor Diversity Program will provide access to opportunities to support economic growth for diversity-owned businesses and communities. Reaching out directly to groups not traditionally included in our procurement process is a key part of our strategy. Ensuring equal access to procurement opportunities for diverse vendors is a priority for CMHC.

Some of the benefits of a diverse vendor program are:

- greater supply chain competitiveness and resilience
- increased innovation through the entrance of new products, services and solutions
- enhanced organizational reputation and brand equity
- increased sales opportunities in diverse markets
- positive socio-economic development gains in diverse communities

The Vendor Diversity Program creates a win-win scenario for Canadian entrepreneurs and diverse vendors and CMHC. Diverse vendors benefit from increased visibility and business opportunities and CMHC benefits from competitive offerings and greater innovation that allows us to deliver the best value to our clients.
