SCORING GRID

Eligible proposals will be reviewed and assessed with input from representatives of Indigenous organizations, CMHC and Indigenous Services Canada. There will be two selection processes, one for shelters in First Nations communities on reserve, and another for shelters in the Territories. Given the limited funding available, priority will be given to proposed shelters that serve the greatest needs. Proposals will be evaluated based on the scoring grid below.

- 0 = Does not satisfy the requirements of the criteria in any manner.
- 1 = Barely addresses any of the requirements of the criteria.
- 2 = Adequately meets most, but not all, of the requirements of the criteria.
- 3 = Meets all the requirements of the criteria.
- 4 = Exceeds the requirements of the criteria in ways which add additional value to the stated requirements.
