Re: Federal Funding – Housing Benefit for survivors of Gender-based violence

I am pleased to provide this agreement (the "2023 CHB Enhancement Agreement") to enable New Brunswick Housing Corporation ("NBHC") to access new funding for the enhancement of Initiative 3 - Housing Benefit described in Schedule B.1 of the Bilateral Agreement under the 2017 National Housing Strategy (the "Bilateral Agreement").

CMHC and NBHC agree that this 2023 CHB Enhancement Agreement enables NBHC to receive new CMHC Funding in the maximum amount of \$10,130,620.64 for survivors of Gender-based violence. This amount, which is in addition to the CMHC Funding provided by sections 6.1 and 6.2 of Schedule B.1 of the Bilateral Agreement, will have a separate target above and beyond the existing HB target and will be specific to survivors of Gender-based violence (the "Survivors of Gender-based violence HB").

The following terms apply only to this 2023 CHB Enhancement Agreement:

- 1. All provisions of Schedule B.1 of the Bilateral Agreement apply to this 2023 CHB Enhancement Agreement, except where there are specific clauses in this 2023 CHB Enhancement Agreement relating to the Survivors of Gender-based violence HB.
- 2. This 2023 CHB Enhancement Agreement shall be deemed to form part of the Bilateral Agreement pursuant to subparagraphs 1.2 and 15.3 of the Bilateral Agreement.

- 3. Except as stated otherwise in this 2023 CHB Enhancement Agreement, all references to HB in Schedule B.1 of the Bilateral Agreement shall be deemed to include references to Survivors of Gender-based violence HB.
- 4. The Parties will work together to ensure that:
 - (a) the Survivors of Gender-based violence HB targets survivors of Gender-based violence; and
 - (b) the program through which it is delivered is consistent with the Bilateral Agreement and all subsequent addendums and additions, including this 2023 CHB Enhancement Agreement.
- 5. Before the earliest of 3 months of the signing of this 2023 CHB Enhancement Agreement or January 31, 2024, NBHC shall amend the Action Plan for Fiscal Years 2023-24 to 2024-25 to include mutually agreed-to Survivors of Gender-based violence HB, including Targets and Outcomes. These mutually agreed-to Survivors of Gender-based violence HB shall be outlined separately from the existing HB in the Action Plan.
- 6. Maximum CMHC Funding for the Survivors of Gender-based violence HB by Fiscal Year is set out below for the initial period beginning on April 1, 2023 to March 31, 2025:

7. CMHC Funding for the Survivors of Gender-based violence HB during the period from Fiscal Years 2023-2024 to 2027-2028 is the maximum amount of \$10,130,620.64 and will be allocated to NBHC in accordance with the relevant Action Plan Periods set out in Schedule C of the Bilateral Agreement, subject to subparagraph 5.2 of the Bilateral Agreement and appropriations by Parliament. The notional amount of annual CMHC Funding for the following years are set out below:

- 8. Commitments of CMHC Funding under this 2023 CHB Enhancement Agreement may be made from and after April 1, 2023 to no later than March 31, 2025.
- 9. NBHC will have the ability to cost-match CMHC Funding for the Survivors of Gender-based violence HB within the existing HB. For greater clarity, all the requirements for cost-matching set out in section 7 of Schedule B.1 of the Bilateral Agreement apply to this 2023 CHB Enhancement Agreement.

10. NBHC shall report on the Survivors of Gender-based violence HB separately from the existing HB target in the Progress Report using tables 1,2 and 3 of Schedule B.1 of the Bilateral Agreement.
