ABOUT THE HOUSING ACCELERATOR FUND

Overview

The \$4 Billion Housing Accelerator Fund (HAF) will provide incentive funding (contributions) to local governments to encourage initiatives that remove barriers to housing supply, accelerate the growth of supply and support the development of equitable, affordable, low-carbon and climate-resilient communities.

The second round of HAF will add an additional \$400 million to the fund. This boost will help more municipalities cut red tape, fast-track home construction, and invest in affordable housing. Since the fund's launch last year, now totaling \$4.4 billion, the federal government has signed 179 agreements across the country to expedite the construction of over 750,000 homes in the next decade. This new \$400 million increase will accelerate the building of an additional 12,000 new homes over the next three years.

Local governments within Canada, including First Nations, Métis and Inuit governments who have delegated authority over land use planning and development approvals are eligible to apply to the HAF.

The HAF is about driving transformational change and creating the conditions for more housing supply over the short and longer term. The HAF is intended to incent applicants to commit to change, show progress and be provided with funding in return. The objective of HAF is to accelerate the supply of housing across Canada, resulting in at least 112,000 more housing units permitted than would have occurred without the program.

Applicants must submit an action plan that outlines their housing supply growth target and the specific initiatives that they will undertake.

ABOUT THE APPLICATION

This guide is designed to assist you in the completion of an application under the Housing Accelerator Fund Round 2.

There are two key components associated with the application process:

- **Part 1:** An excel-based application form (entitled HAF Application Form), which must be uploaded as an attachment within the portal. Information from the HAF Application Form will be needed for Part 2 of the application process (CMHC Portal). Please complete the HAF Application Form (Excel) before proceeding to Part 2.
- **Part 2:** The online portal (CMHC Portal), where the applicant must provide additional information about their action plans.

PART 1: HAF APPLICATION FORM

Part 1 of the application process requires applicants to complete the HAF Application Form. This is an excel based tool that allows you to summarize the current and historical housing data, input the projected housing data (both with and without the presence of HAF), and easily calculate the growth rate and estimated amount of funding.

You should complete this form **prior** to proceeding with Part 2 of the application process (CMHC Portal), as some of the calculated values from this form will be used as an input into the online portal application.

The HAF Application Form has two working tabs: “HAF Round 2 Form” & “Funding Estimator”. Only the HAF Round 2 Form tab requires inputs.

Note: The HAF Application Form must be included as an attachment in the final submission of the application through the CMHC portal.

“HAF Round 2 Form” Tab

Most of the cells in this tab are locked. The unlocked cells are where applicants can input information.

Section B: Targets and Other Estimates

This section will be used to input the details of the projected number and types of housing units that will be permitted with and without the support of HAF funding. This section will automatically calculate the annual growth rate and the annual growth rate percentage change, allowing you to evaluate whether the projections meet minimum program requirements. These values will be required when you are completing Part 2 of the application process in the CMHC portal.

The difference between the number of units with HAF and the number of units without HAF will represent the net increase in permitted units overall. The net increase in permitted units form part of the Action Plan, and applicants will need to outline how the net increase in permitted units can be substantiated through their proposed Initiatives.

Note: The Initiatives section will be completed in Part 2 of the application process in the CMHC Portal.

Important: Ensure a detailed explanation is provided in the comments box if projections vary from the recent trends in your historical building permit issuances (provided in section E of the HAF Application Form). Explanations provided need to clearly explain why the projections differ.

PART 2: CMHC PORTAL

Now that you have completed the HAF Round 2 Application Form (Part 1 of the application process), you can proceed to completing your application in the CMHC Portal (Part 2 of the application process).

Please Note: The HAF Round 2 application will be automatically assigned to the contact in the first round (unless advised otherwise). If it is the same contact as it was for the first round, please proceed to “Step 1 – Returning to the CMHC Portal?”.

If your contact for the HAF application has changed, please reach out to your CMHC rep. If you do not know your CMHC rep, please email general mailbox HAF-FACL@cmhc-schl.gc.ca.

Applications are assigned to specific individuals for privacy reasons, and if you are new contact for the application your profile will need to be tagged to the application.

Step 1: Creating an Account & Profile

The CMHC Portal can be accessed through the HAF webpage at cmhc.ca/haf.

New to the CMHC portal?

If you have used the CMHC Portal before, proceed to the next section, “Returning to the CMHC Portal”.

If you have not used the Portal before, on the Portal login page, select “Don’t have an account? Sign up now” . Enter your email address and click, “send notification code”. An automated email will be sent to your email address with the code. Enter this code in the field for the verification and click “Verify Code”.

Your contact, profile, and application information are saved in a secure database. CMHC is committed to protecting the private information of applicants.

Your personal and organization information is saved under “My Profile” and “Organization Profile”, which you can access at any time.

In the next section, you will be asked to provide contact information for yourself and your organization.

Please Note: To protect your privacy and make sure you receive communications, approvals, and/or payments from CMHC in a timely manner, your organization’s profile will be placed on hold until CMHC can validate the Legal Name and other information and make any necessary changes. While you wait, you will not be able to proceed any further into the application. The timeline for approval should take no more than 2-business days, and once the hold has been removed you can proceed with completing the remainder of the application.

Returning to the CMHC Portal?

Once you log into your account, you will be presented with the “My Applications” page where you may be able to view/access any in-progress or previously submitted applications.

To continue/edit an application that is currently in draft status, click “Applications Assigned to Me” and then select the draft you wish to manage by its “Program” link.

Step 2: Accessing your HAF Round 2 Application

1. Click “Applications Assigned to Me” and locate the “Housing Accelerator Fund Round 2” application.
2. Review the “My Organization” section for accuracy and select Next.
3. Review the contact information for accuracy and select Next. The person listed in this section is the primary contact for the HAF application.

Assigning the Application

You can choose to assign the application to someone else to complete on your behalf.

You will be prompted to enter their email address and they will receive an automated email informing them the application has been assigned to them. You will be able to remove the assigned person and take back control of the application at any time to edit and/or submit.

Once you are ready to proceed, you must agree to the Terms and Conditions of the application. To view the Terms and Conditions, click on the “Terms and Conditions” link to open the document in a new window.

Within the portal:

All fields marked with an asterisk (*) are required fields. All required fields on each page must be populated with accurate information before you can move on to the next step.

As you move forward through the application, the completed pages will be saved automatically.

Partially completed pages—those that are missing required fields—will not be saved.

You may leave the application portal and return at a later time; your application progress will be saved.

Please note: the application portal will time-out after 30 minutes of inactivity. Completed pages of the form will be saved, but if you have partially completed a page and the system times out, that page may not save.

Once your application is submitted, it will be time-stamped and read-only. If you need to make edits to your application, you will need to contact CMHC to have your application returned to you.

Step 5: Initiatives Introduction

HAF 2 initiatives included within the action plan should be aligned to the 10 HAF Best Practices, and were not started prior to the Budget 2024 announcement of April 16, 2024, except as noted below.

CMHC will consider initiatives that were part of the 2023 application to HAF, that are ongoing or have been completed, if applicants continued to implement the activities. For applicants from the Large/Urban stream, a maximum of 3 initiatives from the previous application will be considered, and for applicants from the Small/Rural/North/Indigenous stream, a maximum of 2 initiatives from the 2023 application will be considered.

HAF 2 applicants must commit to implementing 4 units as-of-right bylaws (for applicants from the Large/Urban stream) as part of the action plan or have already implemented 4 units as-of-right prior to application submission. More guidance is available in the Pre-Application Reference Guide.

To facilitate the update of your action plan, initiatives have been copied from your original HAF application. However, the migration of an initiative to HAF 2 does not guarantee its eligibility. It is the applicant's responsibility to review all initiatives and milestones before submission to ensure eligibility under HAF 2.

The following fields have **not** been copied from the original HAF application and will need to be filled out:

- Initiative Estimated Start Date and Estimated Completion Date
- Milestones Estimated Start Date and Estimated Completion Date
- Estimated number of units the initiative will incent within the program and within ten years
- Estimated Cost
- Initiative Assessment Questions

Applicants that are part of the Large/Urban application stream are required to implement a minimum of 7 initiatives. Applicants that are part of the Small/Rural/North/Indigenous application stream are required to implement a minimum of 5 initiatives. For each initiative, you must add a **minimum of 1 milestone per initiative**.

Although these are minimum requirements, applicants are encouraged to add additional initiatives, as required to support the committed housing supply growth target and align with HAF priority objectives. However, only the top 7 (Large/Urban application stream) and top 5 (Small/Rural/North/Indigenous application stream) will be considered in the scoring.

Note: Please refer to HAF Pre-Application Reference Guide for further details about Action Plan initiatives.

Part A – Delete or Edit an Existing Initiative

As part of your HAF Round 2 application, you have the option to resubmit updated initiatives from the first round. You must review each carried-over initiative to ensure its eligibility. If you choose to keep an initiative and resubmit it for the second round, you will need to update it accordingly. Initiatives that will not form part of your action plan must be deleted.

Please ensure to consult the HAF Round 2 Pre-Application Reference Guide for minimum requirements and eligibility of your initiatives.

To Delete an initiative

Click on the dropdown arrow for the initiative you are removing, and select the 'Delete' button. A popup window will open to confirm your choice to delete the initiative.

Note: When an initiative is deleted, the associated milestones get deleted as well. Please be certain when deleting initiatives as they cannot be recovered.

To Edit an initiative

Click on the dropdown arrow for the initiative you are updating, and click on the 'Edit' button. A popup window will open allowing you to make the necessary edits.

After selecting the edit button on an initiative, you will be prompted to complete the following fields:

2. Initiative Type:

This field has been copied over from the original application. Review current initiative type for accuracy and update if necessary. Click on the magnifying glass to display the list of initiatives to select from. Click on the arrow to navigate to the next page to display more initiative types. If your proposed initiative does not fall within the recommend initiative types, select 'Other'.

3. If "Other" please indicate:

This field has been copied over from the original application, if applicable. Only if 'Other' was selected as the initiative, please ensure there is a short description of your proposed initiative. Otherwise, leave this field blank.

4. Describe your initiative, including its goals and objectives:

Please update all information in accordance with Round 2 of the Housing Accelerator Fund.

Remember: An Initiative should provide an outline of your specific initiative and expected outcome(s). Highlight the key aspects that meet the objectives of the program and any changes that are being introduced for the second round. Recommend 3 - 6 sentences.

5. Estimated Start Date:

Enter the (estimated) date that the initiative will start. Initiatives must start/have started after the 2024 federal budget (April 16, 2024), which announced the second round of the Housing Accelerator Fund.

Note: CMHC will consider initiatives that were part of the 2023 application to HAF that are ongoing or have been completed, if applicants continued to implement the activities. For applicants from the Large/Urban stream, a maximum of 3 initiatives from the 2023 application will be considered, and for applicants from the Small/Rural/North/Indigenous stream, a maximum of 2 initiatives from the 2023 application will be considered.

6. Estimated Completion Date:

2. Once successful, your files will be listed under the ‘My Documents’ section.
3. Once you have uploaded all your documents, click on the ‘NEXT’ button, which will bring you to the Submit page.

Note: Documents may not appear immediately after uploading. Proponents may need to refresh the page.


Step 7: Submit
